City of Patterson Downtown Revitalization Committee Regular Meeting Minutes July 10, 2023

1. Call to Order

The regular meeting of the Downtown Revitalization Committee (DRC) of July 10, 2023, was called to order at 5:05 p.m. by Chairperson Benefield.

3. **Items from the Public**

Yolanda Magana asked if this was the group that actively seeks out businesses coming to Patterson. Chairperson Benefield stated that this group's role was to help renovate the downtown. Community Development Director Stice suggested calling the Planning Department with any questions.

Mayor Clauzel wanted to update the DRC on events that were coming up. He spoke about National Night Out on August 1st at North Park. He mentioned that they plan to move the farmer's market that week from Wednesday to Tuesday to have everything on the same date including live music, bounce houses, etc. He also stated that he's working with Mil's restaurant to put landscaping in front of their property to beautify the circle. There's a new restaurant opening on the circle that already beautified their building and the fitness center just opened recently and updated their building as well.

4. Motion to approve DRC regular meeting minutes of June 12, 2023

Committee Member Wright motioned to approve the June 12, 2023, DRC meeting minutes, and the motion was seconded by Committee Member Sidhu with a 3-0 vote.

5. Discussion of downtown master plan

Community Development Director Stice stated that we will receive the draft development standards this week for review and will be submitted for public review during potential City Council/Planning Commission workshop in mid to late August. RRM Design consultants will figure out dates they're available with staff and then a date will be set for the workshop. The consultants will be presenting development standards along with revised circulation, street cross sections, logos, revised signage, and design vignettes.

Downtown Revitalization Committee Minutes July 10, 2023 He mentioned the circle lighting plan diagram that was passed out to the DRC at the last meeting. He stated that it was forwarded to RRM Design, and a proposal was received that will coordinate with RRM Design's work.

Chairperson Benefield asked about a water feature being incorporated into the master plan. Community Development Director Stice stated that there wasn't a water feature vignette, but it doesn't mean that one couldn't be included in the master plan. He stated that there was a lot of input received at the Apricot Fiesta, meetings with the stakeholders, the DRC and previous Planning Commission meeting and City Council workshop and RRM Design will be requesting a consensus at the workshop to bring all the ideas together.

Committee Member Wright would like an implementation date of the master plan and a realistic timeline from RRM Design. Community Development Director Stice stated that Planning Commission and City Council workshop will occur in August and then will come back to the DRC in November or early December to review the first draft of the master plan. He stated that by February or March 2024 the adoption of the master plan may occur.

Albertina Reynoso recommended that the workshop be in English and Spanish and to hold a daytime meeting if possible.

6. Review of downtown short-term projects to present to City Council on July 18th

Community Development Director Stice stated that a presentation to the City Council will be made for their support for a short-term downtown project. Ali Wright will make a brief presentation at the meeting.

There was a discussion regarding different ideas from a member of the public to enjoy the downtown now and promote more activities to get the community to come downtown.
