NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the City Council of the City of Patterson will hold a public hearing on **Tuesday, March 17, 2026, at 7:00 p.m.**, or as soon thereafter, in the City Council Chambers, 1 Plaza, Patterson, CA to consider the following:

ADOPTION OF A RESOLUTION ADOPTING CERTAIN FINDINGS AND APPROVING AN ENERGY SERVICE CONTRACT WITH ALLIANCE BUILDING SOLUTIONS, LLC, AND APPROVING A FINANCE AGREEMENT FOR ENERGY-RELATED IMPROVEMENTS TO CITY FACILITIES.

The City Council Shall hold a Public Hearing For the Purposes of Presenting Certain Findings, Taking Public Comment and Approving a Resolution Adopting Findings and Approving the Energy Service Contract and Finance Agreement for the Implementation and Funding of Certain Energy Related Improvements to City Facilities in Accordance with California Government Code Sections 4217.10 to 4217.18. The City Council's Findings shall provide, and the Energy Services Contract Shall Require, that the Cost to the City to Implement the Energy-Related Improvements Will be Less than the Anticipated Marginal Cost to the City of Thermal, Electrical, or Other Energy That Would Have Been Consumed By The City in the Absence of Purchasing the Energy Improvements.
